ENTRY DEADLINE Sunday July 12th

- Baby (under 2)
- Tiny (2-3 years)
- Little (4-6 years)
- Young (7-9 years)
- Pre-Teen (10-13 years)
- Teen (14-16 years)
- Miss (17-22 years)

Pageant Date/Location/Times

Saturday July 19th at 2:00 pm- Louisa County High School

-The dressing room will be available for teen and miss contestants (as they have an outfit change).

-Baby, Tiny, Little, Young, preteen Miss arrive stage ready

-Stage will open at 1:00 pm for contestants to practice modeling a **T formation** behind closed curtains. More information will be forth coming

-Baby and Tiny Miss is the only division allowed to have an adult on stage with them.

SPECIAL INFORMATION

- In the event of a tie during the tabulation of scores, all divisions will be broken using the highest overall impression score. For the Miss Division, the judges (without interaction from pageant staff) will break the tie; all categories for the Miss Division will be evaluated in breaking the tie.

2026 RULES AND REGULATIONS

Please read the following; signing the application acknowledges your agreement to these rules. The 2026 fair queens are also required to abide by these rules after receiving their title.

1. **ALL contestants must reside in Louisa County**
2. Contestants must be female who has always been female, single, never married, without children, and never having been pregnant.
3. Contestants must possess strong moral character, have never been convicted of a crime, have any pending criminal charges, or have committed an act or engaged in an activity which is or could be characterized as dishonest, immoral, indecent or in bad taste. These regulations also apply to improper images/actions on all social media outlets.
4. All Contestants must enter the division corresponding with their age as of pageant day.
5. Contestant line-up will be determined by the order applications are received by the director (first in, last out).
6. The first runner-up in each age division must be willing to assume all duties in the event that the winner is unable or unwilling to fulfill her duties.
7. The 2026 titleholders are required to attend/participate/abide in the following:
 - Fair Week July 30th- August 1st
 - Other events as requested by the fair board, pageant committee and pageant director
 - **Miss** may Not participate in other pageants during reign prior to Miss VAF.
 - Winners must sit out 1 year before competing to hold the same age group title again.
8. The 2026 Miss Louisa County Fair will compete at the Miss Virginia Association of Fairs Scholarship Pageant, to be held January at The Williamsburg Lodge in Williamsburg, VA. The queen will work strictly with the pageant directors and assigned resources. Additional information will be discussed with the queen. Should the queen choose not to compete it must be approved by the fair board and pageant director/committee.
9. All contestants and family/guests must conduct themselves in a proper manner at all times throughout pageant weekend. Any display of uncooperative and unsportsmanlike conduct will result in immediate disqualification of the contestant and removal of individuals from the property.

All rules, regulations, awards, schedules, and information pertaining to the pageant are subject to change at the discretion of the Director, the Fair Pageant Committee, and the Fair Board, if necessary

QUEEN DUTIES

Winners will be *expected to attend* and help at the fair on **Thursday, Friday and Saturday** July 30th -August 1st (a schedule of fair duties will be given to the winner after crowning). Baby and Tiny Miss will be excluded if parents feel they are too young. Some girls may be asked to do public service duties during the year. Please keep this in mind when entering the pageant.

The **Miss winner** will attend the Miss Virginia Association of Fairs pageant in January. She will also promote her platform throughout her reign. Queen will be responsible for expenses (wardrobe, hotel, etc.).

AWARDS/GIFTS

Across the seven age divisions multiple awards will be presented.

- All seven age divisions: Queen Title/1st RU/2nd RU and the following side awards: Photogenic, People's Choice and Community Service
- Miss Division Only Congeniality, Top Interview Award, Queen Scholarship (minimum of \$500)
- Queen Awards include: Rhinestone crown and Sash, Admission to fair week events

Area of Competition	Divisions	Details
Photogenic	All age divisions (optional area of competition)	Please email headshots to the director by the application deadline. Judged by a panel of judges on pageant day.
Fair Wear	Baby, Tiny, Little, Young, Preteen	Outfit of choice (sundress, shorts outfit, something you would wear for the summer or to the fair, see attire requirements on page 2). Judging will focus on appearance, outfit, personality, poise, and overall impression.
Interview	Teen and Miss Only	Five-minute panel interview with judges, judging focuses on personality, poise, speaking/conversational ability, and overall impression. ***interview will be held the day of the pageant before 12:00 pm- times will be scheduled the week of the pageant.
Personality Wear	Teen, Miss	A <i>casual</i> outfit of your choice that best displays your personality is to be worn. Judging will focus on appearance, outfit, personality, poise, and overall impression. Outfits that could serve as evening wear are NOT permitted
Formal Attire/Gown	Teen, Miss	Gown/Dress of Choice (see attire requirements on page 2). Judging will focus on appearance, gown, personality, poise, and overall impression.
On-Stage Question	Pre-Teen, Teen and Miss	An on-stage, unrehearsed question to identify the impromptu public speaking ability of each contestant.
Community Service	All Contestants (optional)	The winners will be determined by which contestant donates the most for each age division. (see page 4)

Interview:

You will complete a 5-minute panel interview prior to the 2 pm pageant. Interviews will be conducted on the day of the pageant, July 19th. Interviews will begin around 11:30 AM (exact start time will depend on the number of contestants). You will be emailed your interview time on July 12th.

Application and Resume:

You may hand write the application sheet on the page prior, it will only be used by pageant staff for your bio to be read during the pageant.

In addition to your application you will need to turn in a **typed resume**. Please **email or attach a copy of your resume with your application**.

Please limit your resume to **one page** and your response to the short answer questions to one page.

Your resume is a fact sheet about yourself. If you look at the interview and the whole pageant process as a "job interview" then you will most likely do your best. The judges are looking for someone to fill the JOB of holding the title of "Miss Louisa County Fair." The judges will receive a copy of your resume before meeting you so it will be their first impression of you before you even enter the room. The judges are instructed to take grammatical errors into consideration when scoring your interview. Have as many people proof read your resume as possible. The required resume format has been included on the next page.
